The Integrated Review at 2: integrating the Early Years Foundation Stage Progress Check and the Healthy Child Programme health and development review

Our tailored support will offer help to local areas that will be expected to integrate health and education child development reviews that are carried out and shared with parents when children are two years of age.

The Early Years Foundation Stage (EYFS) Progress Check at age two (delivered by early years practitioners in a child's early years setting) will be brought together with the Healthy Child Programme (HCP) 2 - 2½ year old health and development review (delivered by health visiting teams), where possible, in an Integrated Review.

Combining the two review processes offers the potential to provide better and earlier intervention to support children's future outcomes. Age 2 is a key point in development where problems such as speech delay or behavioural issues may begin to emerge. Integrating health and education reviews at this age can help identify problems and can also reduce the risk of duplication and confusion in making referrals for those children who need more support.

What is on offer?

The package will enable leaders and commissioners to look at where they are in the process of getting ready for delivering the Integrated Review at 2 – 2½ years to promote early identification and intervention to improve children's outcomes. By identifying training needs and bringing together practitioners and managers from across the range of services, a focused training day will support the next stage of preparation towards delivery. An experienced associate will lead the day which could cover areas such as:

- finding out about the policy context concerning the integrated review
- considering the importance of partnership with parents and of getting to know children and families well
- reflecting on ways of identifying a young child's progress, strengths and needs in order to promote positive outcomes in health and wellbeing , learning and behaviours
- identifying the importance of quality services for two year olds by considering development needs and histories that individual children bring
- relating experience with theory and research regarding two- year- olds and young children's development
- identifying areas of change that would lead to improved ways of working between services
- increasing awareness of how to facilitate appropriate intervention and support of children and their families especially those for whom progress is less than expected
- considering how to generate information which can be used to plan services and contribute to the reduction of inequalities in children's outcomes
- creating an action plan for delivery of the Integrated Review

The training day will be followed by a half day de-briefing session which will review progress and identify next steps for implementation.
